MATTERS PRESENTED BY STAFF

Director's Report

Carrie continues to meet and discuss with Council the new facility. There is strong support for a new facility and the Strawberry Field is the preferred site. The size of the Library, amenities and financing are the main focus.

Carrie is in the process of completing the State Report, a large statistical report where the state collects information from public libraries. The report is due December 5, 2015.

A digital version of the approved Strategic Directions is currently on the website. It has the ability to be "flipped through" like a magazine.

In an effort to expand services to the Yorba Linda Community, the Library is now offering 3D printing services. Nominal fees are associated with each print job. Additionally, the Library has started offering digital magazines again, through a service called Flipster, which can be found on the Library's website.

The Annual Food For Fines program has started and will run through December 19, 2015.

The low flush toilets were installed, however, due to aged plumbing, several leaks needed to be dealt with. A plumber had to be called and the water in the entire building had to be shut off for some time during non business hours.

The Senior Clerk position is currently open and will be closing on November 13th, 2015.
